## Re: New 3G Astro

I hope you all enjoyed a restful half term break.

I am delighted to let you know that our new 3G Pitch has officially been completed and signed off by the Football Foundation during the Half Term Holiday!

This means that we are hopeful for a soft launch with our students as soon as possible (planned for week commencing 3<sup>rd</sup> March), and a Grand Opening on Friday 4<sup>th</sup> April to celebrate all the amazing efforts by students, staff, Partner Football Clubs and other members of the local community.

We are extremely proud to have been awarded the funding by the Football Foundation for this wonderful asset, but I must stress the importance of regulations that we must adhere to in order to ensure the longevity of the pitch and adhere to Football Foundation Terms & Conditions.

All users of the pitch (both staff and students) must wear regulation footwear.

- Moulded blades or rubber studded footwear only
- No spikes, metal studs, trainers or heeled shoes
- Astro Trainers are also NOT permitted



Moulded blades or rubber-studded footwear ONLY

NO spikes, metal studs, flat-soled trainers or heeled shoes

No food, chewing gum, glass bottles or canned drinks are permitted. Only plastic water bottles.

Failure to comply with these regulations will result in the voiding terms and conditions applied by the Football Foundation and the voiding of any warranty, which would mean the loss of this amazing resource for OSCA and the community, so there really is no exception.

I appreciate that not all of our students may currently have the required footwear to use this facility, and so we will be purchasing a bank of footwear that can be loaned to students during their PE lessons if required. This will be allocated on a first-come, first-served basis and returned to PE at the end of the lesson.

I would really appreciate it, if you could take the time to complete the following survey to notify us what footwear your child will opt to use – this will enable us try and order sufficient numbers of boots for the loan bank, and sufficient sizes: <u>https://forms.office.com/e/BPcshBuLpZ</u>
